- Open Space Alliance (OSA) will retain 30% of the pre-tax painting price as a charitable contribution.

SIZE & FRAMING REQUIREMENTS:

Image: 4" x 6", 5" x 7", 6" x 8" maximum (square

format allowed, 48 sq. in. maximum)

Frame: 14 x 16 max. outside dimensions.

Work must be sturdily framed and ready to hang.

No sawtooth hangers.

Simple or plein air style requested.

DIGITAL REQUIREMENTS: 700 pixels longest side, 72 dpi. Title each jpg image as follows: First 4 Letters of Last Name, First Initial, Painting Title.

Or, paintings may be shipped directly to the Open Space Visitor Center, as long as prepaid return shipping documents and carton(s) are supplied when paintings are delivered to the show. Cost of shipping painting(s) to and from the show is the responsibility of the artist.
