

# PAPNM 11th National Juried Members Exhibition Prospectus

#### **About**

- The 11th National Juried Members Exhibition is a juried show and sale of original two-dimension en plein air artworks presented by the Plein Air Painters of New Mexico (PAPNM) and hosted by Santa Fe Art Collector in Santa Fe, New Mexico from Friday, October 4 through Sunday, October 27, 2019.
- Juried artists will compete for awards valued over \$15,000 in cash and merchandise prizes.
- This call is only open to current (or new) paid PAPNM members.
- To join PAPNM, visit www.papnm.org, and click "Join Us" in the top menu.
- The public and collectors are invited to attend the opening reception and view the exhibition at Santa Fe Art Collector, 217 Galisteo, Santa Fe, NM 87501.
- PAPNM is a 501(c)6 non-profit organization of artists dedicated to preserving and promoting painting "en plein air" in the open air or outdoors.

# Eligibility

- Open to all paid members of PAPNM plein air artists working in two-dimensional media excluding photography and digital art. Accepted media is limited to oil media (traditional and water- mixable), wet media (acrylic, watercolor, and gouache), and dry media (colored pastel and pencil).
- PAPNM artists of the following levels are eligible for this event: artist members, signature members, master signature members.
- PAPNM Master Signature Members will receive a separate email invitation from the exhibition committee and need not apply through CallForEntry (CaFÉ™) nor pay entry fees.

# **Entry Fees**

- Each artist will need to submit 3 images. Three entries will cost \$55 (non-refundable) paid via CaFÉ™ www.callforentry.org. If you want to submit a 4th it is an additional \$15.
- A <u>maximum of 3 artworks may be selected</u> for exhibition from each artist.
- If artists are having trouble with CaFÉ™ process, go to the help menu on CaFÉ™ www.callforentry.org for assistance.
- Artists should check their CaFÉ™ accounts <u>before 08/30/2019</u> to verify application status. Upon completion of jury selection, artists will receive notification of acceptance or decline by email.
- Jury result notification will be emailed on 09/06/2019. Along with the jury notifications, accepted artists will receive information about delivering their art to the gallery.

# **Image Entry Requirements**

- Each artwork entered must be within size specifications. The minimum size per piece is 80 square inches unframed (8"x10"). Maximum size per piece is 320 square inches unframed (16"x20"). Works smaller or larger will be withdrawn from jury consideration and shall not be replaced with another entry.
- Artists submit 3 to 4 images of works online for jury consideration at CaFÉ™ www.callforentry.org.
- All submitted work must be at least 80% completed en Plein Air on location within the past two years. Works painted prior to 09/01/2017, will be withdrawn from jury consideration and shall not be replaced with another entry.
- Works must not violate copyright laws. All work must be original concept and painted solely by the entering artist.
- Works shown in any <u>previous PAPNM juried member exhibition are not eligible</u> for entry.
- Works previously <u>showcased in PAPNM on-line contests</u> are eligible for entry.
- Work done under the guidance of an instructor are not eligible for entry.

# **Participation Requirements**

Artists accepted into the event agree that the accepted artwork hang in the gallery for sale for the duration of the event at stated commission.

#### Exhibition

- Location Santa Fe Art Collector Gallery, 217 Galisteo, Santa Fe, NM 87501.
- Painting and Hanging Requirements:
  - Created at least 80% en Plein Air on location.
  - The minimum size per piece is 80 square inches unframed (8"x10").
  - Maximum size per piece is 320 square inches unframed (16"x20").
  - Minimum price point required by gallery is \$375 for all hung work.
  - All work must be sturdily framed or gallery wrapped and ready to hang with D-rings and wire. No saw tooth hangers will be accepted.

# Commission

- All artwork must be for sale. Santa Fe Art Collector Gallery will handle all sales. Santa Fe Collector Gallery will handle sales tax.
- Artists will receive 50% of the sale price of the work. Payment to artists will occur within 30 days of the close of the exhibit.
- All possible care will be taken of the work submitted to the event. The gallery will not assume responsibility for work improperly framed. Work will be insured by the galley while at Santa Fe Art Collector.

- Each artist will need to submit 3 images. If you want to submit a 4th it is an additional \$15.

However, Plein Air Painters of New Mexico, its members, and its volunteers are not responsible for any loss or damage to any artworks in the exhibition. Santa Fe Art Collector Art Gallery will be responsible for the safekeeping and insurance coverage of all artworks in the exhibition while on gallery premises. Artists are responsible for insuring their work during transit.
- The artist retains copyright to his/her image(s). However, by submitting to this show, the artist agrees to PAPNM's and Santa Fe Art Collector Gallery's use of the images for publicity (including future promotion) and archival purposes.
- An artist's entry and payment constitute acceptance of all conditions and terms in this prospectus.
